



Terms and Conditions for LDRC Training

1. Acceptance of Terms:

- By registering for and participating in equestrian training events offered by Ludlow & District Riding Club ("the Club"), you ("the Participant" or "you") agree to be bound by these Terms and Conditions.
- Please read these Terms and Conditions carefully before registering. If you do not agree with these Terms and Conditions, do not register for any training event.
- BRC Rules apply at all LDRC events.
- Horses & Ponies must be 4 years old and over to take part in any ridden club activity.
- Horses & Ponies can be 4 years old and under to take part in any in hand club activity.

2. Registration and Payment:

- Registration and payment for training events is completed online via the clubs My Riding Life account.
- Full payment for the selected training event is required at the time of registration to secure your spot
- Payments for training events are non-refundable once times have been issued. A refund or credit can be issued at the club's discretion if your space is filled. This includes, but is not limited to, cancellations by the Participant for any reason, including illness, injury, change of personal circumstances, or any other unforeseen event.

3. Event Changes:

- The Club reserves the right to modify the training event schedule, instructors, content, or location at any time, without prior notice. While every effort will be made to maintain the event as advertised, changes may be necessary due to unforeseen circumstances.
- The Club reserves the right to cancel a training event due to insufficient enrolment, instructor unavailability, adverse weather conditions, concerns about horse welfare, or other unforeseen circumstances.

- In the event of cancellation by the Club, Participants will receive a refund less the service fee.

- In the event of a significant change to the event, the Club will make reasonable efforts to notify Participants.

4. Participant Conduct and Health & Safety:

- Participants are expected to conduct themselves in a respectful and sportsmanlike manner at all times. This includes respectful interactions with instructors, other participants, horses, and Club staff. The Club reserves the right to refuse participation to any individual who exhibits disruptive, disrespectful, unsafe, or unethical behaviour.

- Participants are responsible for ensuring they are physically fit and capable of participating in the training event. Riding is a potentially hazardous activity, and participants should be aware of the inherent risk; Participants acknowledge and assume all risks associated with horse riding and related activities, including the risk of falls, injuries from horses, and other potential hazards.

- Participants are responsible for providing their own appropriate riding attire and equipment including, but not limited to, a properly fitted riding helmet.

- Horses & Ponies must be fully vaccinated in line with BRC rules. A vaccination checker can be found on our website. Passports must be always carried when travelling you horse.

5. Photography/Videography:

- The Club may take photographs or videos during training events for promotional purposes. By participating, Participants consent to the use of their image and likeness in such materials. If you do not wish to be photographed or filmed, please inform photographer or videographer. For any questions or concerns regarding these Terms and Conditions, please contact our Secretary Sarah Burden.

- The Club reserves the right to amend these Terms and Conditions at any time without prior notice. It is your responsibility to review these Terms and Conditions periodically for any updates. Your continued participation in training events following any amendments constitutes acceptance of the revised Terms and Conditions.
